During today's meeting, committee member Sue Bay will serve as secretary, Becky Hale will serve as parliamentarian, Cathy Snyder will be the keeper of the doors, and Wendy Homyak will serve as time keeper.

Becky Hale came forward and announced that 31 of 53 chapters are present. A quorum has been established.
