ADDITIONAL Presidential Bonanza Bonus Points (100 points) if all five copies of the following are submitted with your documentation.

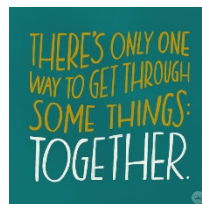
- Sales and Use Tax Permit

Lifecycle of a Chapter

Do you know someone who would love to have a Women of Today chapter in their community, but they don't? Or maybe YOU live somewhere that doesn't have a chapter? This idea for a chapter is a "Prospective Extension".

When a community has been identified as having an interest in the Women of Today, an Extensions Team is formed and an Intent to Extend form is filed with MNWT. The team (an individual, chapter or district) sets up informational meetings in the area to attract prospective members. New members are signed up and once there are at least 10 members, a new chapter has been started and can charter.

What does "Two and Under" mean? This is a chapter that is in its first two years after chartering. During this time, the Membership Team and Extension team are committed to actively supporting these chapters with training, helping with projects, and guiding in growth. After two years, a chapter graduates as a full-fledged chapter.
