Do not know much about the MNWT Foundation? That is okay. There is a lot to know about the MNWT and the Foundation is a part of that.

The MNWT Foundation has Committees chaired and organized by various Foundation Board members: Scholarship, Chapter Grants, Endowment Fund, Corporate Solicitations, and Planned Giving.

As you may have read above, the Scholarship Committee handles the Cheryl L Anderson Scholarships, Straight River Scholarships and the Winter State Jewelry Auction.

Chapter Grants, reviews chapter applications awarding grants to chapters for their projects.

Become a Sustaining Member

For an annual \$25 donation you, your chapter, district, or all of the above, can become sustaining members of the Foundation. Funds are used at the board's discretion to support the mission of the MNWT. Funds have been used for the membership rebate program, for PE courses, to pay for speakers at convention, to support the President/State Delegate retreat and many more programs. This committee also organizes the Fall State Lucky Buck Baskets to fund the grants program.

Endowment Fund works to set up our Endowments Funds and helps with other fundraising.

Corporate Solicitations assists chapters to secure grants through the Foundation. Those donations, grants are then donated back to chapters with a 1% fee. This committee also manages various other funding opportunities.

Planned Giving, solicits sustaining membership donations and has also recently completed a brochure on how to plan giving to the Foundation.

Cheryl L. Anderson/ Straight River Scholarships

Cheryl L. Anderson Scholarship

Cheryl was a member of the Anoka Women of Today for 9 years. She served her chapter and the state organization in many positions including President of the Key Women Club. She was an art teacher and unfortunately passed away in 1989. One of Cheryl's unfulfilled goals was to return to school and further her education in school counseling. Her goal lives on in this scholarship.

To be eligible, you must be a member in good standing for 2 or more years and entered college with an approved program. You must show a need for financial assistance. Applications are due by **August 1st** and will be awarded at Fall State.

Straight River Scholarship Fund

This scholarship is funded by the Straight River Women of Today. Their chapter consisted of members who have physical and developmental challenges. They ran many of the same fundraising projects as other chapters do. This scholarship is for the members who are furthering their education in an area to help those who are physically or mentally challenged.

To be eligible, you must be a member in good standing for two or more years and seeking to further your education in a field related to working with mentally or physically challenged people. Applications need to be submitted by **Aug 1st, January 1st, and April 1**st (anytime) for the Foundation Board to consider awarding a scholarship in conjunction with our meetings.
