## What does a Parliamentarian do?

Congrats on taking on the role of Parliamentarian for your chapter or district. It may seem like a huge task. You are probably asking yourself, what does the Parliamentarian do? The job of a parliamentarian is to be proactive, to follow Robert's Rules of Order, establish a quorum at each chapter meeting and to keep bylaws/policies up to date by holding a Bylaw and Policy Review each year.



# Something new is in the works.... One of my goals for the year is to create a *District Bylaw/Policy Repository*. This will be a place where all District Bylaws/Policies are stored. After creating the District's repository, I would like to then start a chapter one. The goal would be for chapter parliamentarians/presidents to have someone to go to if their chapter misplaces their chapters.

Have motion slips with you at every meeting. Give the order of the day at the beginning of each meeting, make sure to establish a quorum.

# ORDERS OF THE DAY

For Chapter Meetings

- Please have all cellular phones turned off or in silent mode during the business meeting.
- As a matter of courtesy, please do not enter or leave the room when a speaker has the floor.
- A motion slip must be prepared and given to the secretary.
- Any member in good standing may present a motion, enter into discussion and vote.
- Please keep all motions in the positive.
- If you disagree with a motion, do not hesitate to vote no or abstain.
- Please be ready to second a motion to help expedite the business.
- (Seconding simply means you would like to discuss the motion.)
- A quorum has (not) been established.
  - (A quorum is the number of voting members who must be present in order that business can be legally transacted. This should be stated in your bylaws and can vary from chapter to chapter.)

#### MOTIONS

#### What is a motion?

• A motion is any proposal that introduces business to a group.

#### How to Present a Motion

- 1. Rise and address the chair "Madam President..." for example.
- 2. Be recognized by the presiding officer.
- 3. State your motion "I move..."
- 4. The motion needs a second by another member of the group.
- 5. The presiding officer states the motion as presented "It has been moved and seconded that..."
- 6. Discussion is held, and the person who made the motion has the chance to speak first and present his/her reasons for the motion.
- 7. A vote is taken.
- 8. The presiding officer announces the result of the vote and action is taken.
