Bylaw Change Notice

Here is the notice about a Bylaw Change that will be voted on at the Business Meeting at Annual Convention. This bylaw was suggested at the October Bylaw and Policy review.

I move that we remove on the second or third Saturday and change to take place in March in Bylaw ARTICLE V. MEETINGS Section 2. D.

Currently it reads: March Planning shall be a planning session where present staff shall report on and make recommendations in their area for the coming year. This meeting shall take place on the second or third Saturday in March.
